(AGE 5 BY DECEMBER 1, 2019)**

Required documents:

- Original birth certificate.
- Immunization records (see reverse side).
- Proof of residency: Town of Brookhaven Tax Bill, Deed, Mortgage Statement, Lease with two (2) current bills, or district's signed Affidavit of Landlord with copy of landlord's tax bill, available at Central Registration.
- Custody Papers if applicable.

THE REGISTRATION PROCESS IS NOT COMPLETE UNTIL ALL MANDATORY DOCUMENTATION HAS BEEN SUBMITTED. YOU WILL RECEIVE A CONFIRMATION E-MAIL FROM OUR CENTRAL REGISTRATION OFFICE.

Medical Requirements

School Year 2019-2020

In order to have your child registered for Kindergarten for the Fall of 2019, the following items must be completed:

1. **The following required immunizations must be done:**

- Four or more doses of DTP.*
- Three or more doses of Polio vaccine.*
- Two doses of measles , mumps, rubella vaccine:
The first dose administered after 12 months of age
- Two doses of varicella vaccine:
Administered after 12 months of age.
- Three doses of Hepatitis B.*

* Number of doses may vary.

2. **Proof of immunization must be signed and stamped by your child's physician.**

3. **For School Entrance in September:**

- The physical examination must be performed within one (1) year prior to the first day of school and Physical Form returned to School Health Office with physician's signature and stamp.
4. NYS requests that students enrolling in pre-kindergarten, kindergarten or first grade in a New York State public elementary school present a dental health certificate; such dental health certificate must contain a report of a comprehensive dental examination performed on such child.
