

For all students that participated in state assessments the previous school year receives their score in the beginning of the new school year. Our students and parents are provided with the New York State regulations regarding State Assessments and the majority of our students and parents opt out of state testing by choice. We start to receive opt out letters from parents 2 weeks prior to state testing and we continue to receive opt out letters until the day of each examination which resulted in participation rate falling below 95%.</p>
